Call to order: 9:05 AM

Motion from Larry Freitag, second by Betty Schneider to accept the 2007 Annual Meeting Minutes. Motion carried unanimously.

WDNR Secretary Matt Frank made a presentation updating the gathering on current WI conservation issues, followed by a question and answer period.

President Lil Pipping presented a special Stewardship Award for Governor Doyle. Secretary Frank accepted the award on the governor's behalf. A short acceptance video was shown.

**President's Report: Lil Pipping**

President Lil Pipping personally thanked Lonna Zeman, Meg Nelson and Ruth Ann Lee for all their hard work in planning the annual meeting.

Lil addressed how the Federation has worked very on Stewardship, Great Lakes Compact, the Youth Mentor Bill and much more.

The Federation is working on our By-Laws, creating a new calendar committee, youth involvement and building stronger relationships with District Directors. In addition, we need to continue our commitment in completing the Camo Coalition.

Emergency Resolution 5. Shooting Range Protection Bill. Motion by Rick Lazarczyk and second by Jerry Peters to allow emergency resolution 6 to be read. Motion carried. Emergency resolution 6 was read by Secretary Hau.

**Resolution Voting:**

Motion by Mike Brust and second by Pete Zuba to adopt Emergency Resolution 1, a resolution asking the Federation to stand against expanded use of crossbows during the archery-only season. Discussion followed. 36Aye 12 No 4 Abstain. Motion Carried.

Motion by John Czerwonka and second by Dale Zaug to adopt Emergency Resolution 2, a resolution asking the Federation to create a permanent hunter education program and practices committee. Discussion followed. Motion failed.

Motion by Rick Lazarczyk and second by Ken Barbian to adopt Emergency Resolution 3, a resolution asking the Federation to support allowing whitetail deer to be field quartered. Discussion followed. Motion failed.

Motion by John Czerwonka and second by Mike Rynearson to adopt Emergency Resolution 4, a resolution asking the Federation to restore funding for shooting ranges. Motion carried.

Motion by Rick Lazarczyk and second by Larry Vanderhoef to adopt Emergency Resolution 5, a resolution asking the WWF to begin drafting language for a Shooting Range Protection Act. Motion carried.

Motion by Ralph Fritsch and second by Steve Pease to adopt Emergency Resolution 6, a resolution directing the WWF to ask the DNR to once again collect buck fawn harvest data and to include "how to ID a buck fawn" section in the hunting regulations pamphlet. 29 Yes 15 No 6 Abstain
